Sydney Steele, Legal Aid of Western Ohio (LAWO) Advocate, would like to inform WVI members of their legal resources for Veterans.

"LAWO's Veterans Project provides free legal representation to income eligible Veterans and their families for noncriminal legal issues including housing, public benefits, homeownership preservation, domestic relations, expungements, consumer rights, and bankruptcy. We can assist those who live within our 32-county services including: Allen, Ashland, Auglaize, Champaign, Clark, Crawford, Darke, Defiance, Erie, Fulton, Greene, Hancock, Hardin, Henry, Huron, Logan, Lucas, Mercer, Miami, Montgomery, Ottawa, Paulding, Preble, Putnam, Richland, Sandusky, Seneca, Shelby, Van Wert, Williams, Wood, and Wyandot.

#### Safe Travel Information

Every VA facility has a Traveling Veterans Coordinator (TVC) to help Veterans who are traveling outside their home facility for extended periods. If medications, injections, blood tests, or any type of medical follow-up is needed during, the TVC will help pre-plan the veterans care. Prior to traveling inform the Patient Aligned Care Team (PACT) of your travel plans.

While you are traveling, for non-urgent care questions call 734-845-5290. To find the nearest AUTHORIZED urgent care center call 833-483-8669 or go to www.va.gov. Click on "Find a VA Location" and be sure to use the "Facility Type" drop down menu to choose the correct type of service.



For EMERGENCY CARE during travel go to the nearest VA or community Emergency Department/urgent Care. If you have visited a non-VA EMERGENCY ROOM or admitted contact the Centralized Emergency Care Notification Call Center 24-hour Service Line: 844-724-7842 within 72 hours.

Jacob Healy, Veteran Outreach Program Specialist, writes "Toledo Vet Center is a VA community-based counseling center that provides a wide range of social and psychological services, including professional counseling to eligible Veterans, service members, including National Guard and Reserve components, and their families. Counseling is offered to make a successful transition from military to civilian life or after a traumatic event experienced in the military to include military sexual trauma (MST). Individual, group, marriage and family counseling are offered in addition to referral and connection to other VA or community benefits and services. Vet Center counselors and outreach staff, many of whom are Veterans themselves, are experienced and prepared to discuss the tragedies of war, loss, grief and transition after trauma.
